All papers should be submitted via the online submission system of the Congress at <https://iaaer.ase.ro>. Only full papers will be considered. Submitted papers are subject to blind review by two referees.

Submission deadline: June 30, 2018.

Accepted papers are eligible for the JIFMA Best Paper Award. JIFMA also offers a fast-track review of papers accepted for presentation at the World Congress.
