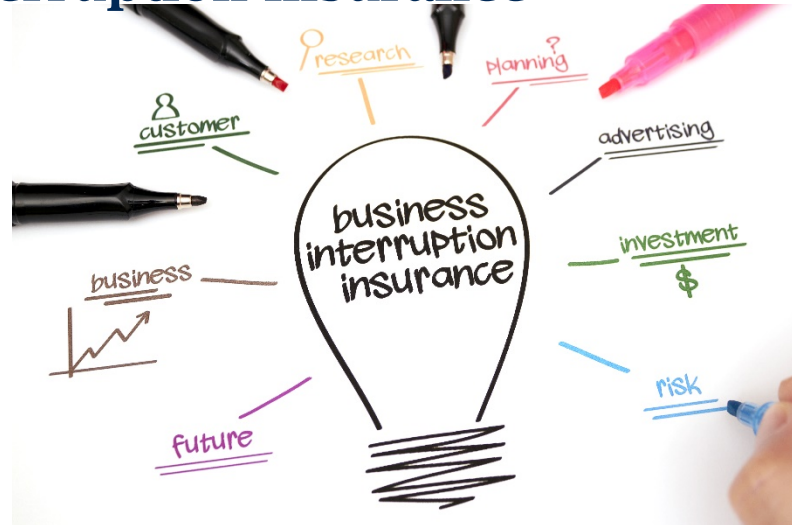


Introduction to Business Interruption Insurance
