Chairman's View

Challenges lie ahead

As the year closes, Rhino Ark now faces some exciting challenges.

It can also proclaim some great achievements.

The most historic is the completion of the Aberdare fence on 28 August 2009. The Minister of Forests and Wildlife placed the final post. Hundreds of forest edge farmers were there to celebrate too as were some of Rhino Ark's founding funders and volunteers. (See pages 8-9)

The 21-year project to build what is surely the world's longest (we have registered with the Guinness Book of Records and await consideration) wildlife conservation fences, successfully creating harmony with its neighbouring forest edge farmers – hundreds of thousands of them, has given hope to millions and dramatically improved the incomes and welfare of its neighbouring farmers.

What of the challenges?

The fence is working. Every day our fence scouts – 100 of them – patrol it, keep it clear of overgrowth, monitor unsanctioned activity along its near 400 kms and create contact mechanisms between the fenceline farmers and the forest and national park authorities responsible for its conservation. But the whole exercise is drastically under financed. Rhino Ark's immediate task is to vigorously pursue the process of securing the funds and requisite legal framework in which the Government meets civil society's expectations.

Rhino Ark has been vocal (and outspoken when necessary) in calling for assertive management and investment in our vital 'water towers' and insisting that they will be best protected by a partnership process of stewardship. Government working alone has a cupboard-full of skeletons – forest management failures. Kenyans today are paying the price of a generation of wanton compromises, abuses of responsibility and blatant theft of state assets. Rhino Ark is now a part of the reversal of this downward trend.

The Aberdare fence has cost upwards of Kshs 750 million. It is currently being maintained for an annual cost of approximately Kshs 10 million only from donations to Rhino Ark and inadequate funds from the Government channeled through the Kenya Wildlife Service. In addition Rhino Ark continues to outlay major capital injections for radios, vehicles, guard posts, accommodation for the fence scouts, training the scouts and the related management costs. No funding support is provided yet by the Kenya Forest Service (KFS), despite its proven value to the KFS in reducing abuse of precious forest assets.

80 per cent of the fence runs on or near state forest borders – secure at last – but still porous due to inadequate funds for maintenance and lack of a fully transparent and enforced fence access policy. The remaining 20 per cent borders the national park. The fence urgently requires Kshs 40 - 50 million annually to ensure the fence itself, the gates and the ecosystem are fully managed. It has already proven that huge savings in assets and supervision overheads are being achieved. This remains Rhino Ark's major challenge.

But we are looking to the future. We have a track record of real achievement. We have a world-class fund raising mechanism of our own The Rhino Charge and are attracting more and more bilateral and global conservation NGO support.

We are mindful of auditing ourselves. Our Rhino Charge sites have been subject to environment audits and this exercise will continue. With considerable support from the United Nations Environment Programme (UNEP) and active involvement of the East African Wildlife Society's Forest Working Group, we are undertaking an environment assessment (EA) of the now completed fence. NEMA, KWS, KFS and the Greenbelt Movement are part of its task force now in place. (See page 27).

We will solve the immediate issues of long term management for the Aberdares; but in turn we are starting to look at what more we can do to secure ecosystems that with sound policy and management practice could become hugely beneficial for the people of Kenya.

The Moorland Road – NEMA rejects license. Rhino Ark's consistent objection to this ecosystem threatening project – a full tarmac highway over the fragile Aberdare moorland water catchment at altitudes of over 3000 meters – and its enlisting the support of major stakeholders and conservation national bodies has been supported by NEMA. This month NEMA has rejected a license to the Ministry of Roads to build the road inside the forest and national park. The budgeted cost was to be over Kshs 1.2 billion!

Millionaires – almost one in every two entrants

The Mogoswok 09 Rhino Charge recorded more millionaire heroes than ever before.

24 of the 60 entrants – an impressive 40% – cracked the million shilling barrier. This beat last year's 19 and the 2007 total of 20.

Even more revealing was that 12 pledged a million and all but one achieved it and a further 10 competitors surpassed their Kshs 500,000 by over 100%.

Of the 24 millionaires – five topped the Kshs 2 million mark thus more than doubling their pledge. Alan McKittrick's Team Five with Alan driving for the first time this year, and his fund raise superstars John Trundell, Nick Hutchinson, Tim Jessop, Tom Porter and Guy Jack raised the most and took the coveted top prize of *victor ludorum* – highest fund raise to distance by formula. Alan McKittrick's ability to goad the millionaire pack into attempts to 'top car 5' continues to elude. Though there are murmurings amongst entrants that it is by no means a done deal year-in year-out, and the determination to pip Car 5 to the top slot is very much out there amongst the top millionaires. McKittrick's Car 5 total in 20 years of Charging has surpassed the Kshs 50 million mark with an exact total of Kshs 56,347,244.78.

It was just 4 years ago that Car 5 overtook the blockbuster performance of the late Mike Higgins and his street standard Car 22 - the 20 year old Niva Lada that between 1990 and 2008 when Mike and his wife Sarah retired from Charging raised Kshs 39,607,239.

Those hot on Car 5's heels include some veteran and skilled drivers any of whom could achieve the most funds raised and a *victor ludorum* win. Second highest fund raise in 2009 at Mogoswok was the Hog Charge Car 35 of Mark Tilbury with Kshs 3,316,397. Their overall kitty in 12 years of Hog Charge successes now totals Kshs 17,069,211.

In third fund raise slot came Ben Woodhams' Team Thirty Nine with Kshs 3,001,723 followed closely in fourth fund raise place by the Charge Fanatic Avery family team of Bundufundi with Kshs 2,855,967. Trustee Jonny Havelock of Car 32 –the dark horse - took fifth place with an impressive Kshs 2,408,891. Jonny was hugely helped this year by the Welles and McKennas father and son additions all the way from Connecticut.

"This event is like nothing on earth. If more Americans knew about it, and especially those with a thirst for adventure and tough off-road challenges, there will be many knocking on the door soon", Chris Welles described it. The Welles and McKennas have signed up again for 2010.

But it is those lower in the fund raise ladder where the spotters are looking to see who will crack the Kshs 2 million mark in 2010.

Special commendations go to teams 44 and 56 who entered the millionaires stable for the first time and finished the event.

Then there are the big fund raisers and constant achievers amongst the all girl teams – the Sapiehas and hugely deserved *Coupe des Dames* winners with over a million in Car 47, and Tanya's Church's Car 17 Team Rouge who were just short of Kshs two million and a finisher despite 'No GPS'.

Special recognition too for all who did achieve their Kshs 500,000 pledge and were able to sign on again for the 2010 Rhino Charge.

The date for the event is confirmed for May 31 next year.

“BEACON OF HOPE”... THE FINAL POST

Just under 400 kms – finally – the Rhino Ark Aberdare Fence was completed at a lively ceremony attended by hundreds of Aberdare farmers on August 28th, 2009.

One of Kenya’s most ambitious, entirely home-grown conservation initiatives started 21 years ago, the Rhino Ark fence is living testimony that threatened mountain ecosystems can be secured.

In bright sunshine Hon. Dr Noah Wekesa, the Minister of Forestry and Wildlife hefted a 3 meter long plastic post weighing 38 kilos and placed it into the ground at Geta, the area linking the Main Aberdares with Mt. Kipipiri. His action also completed the 45.5km Kipipiri Extra Section of fencing which now secures this precious water catchment mountain and includes a linking 4km wildlife corridor. Minister Wekesa was accompanied by his Permanent Secretary, Mohammed wa-Mwachai, the Director of KWS, Julius Kipng’etich and Deputy Director KFS Emilio Mugo.

Colin Church, Chairman of the Rhino Ark Management Committee said: “This is a historic moment for literally millions of Kenyans who are either benefiting from the stability that the fence has given the forest edge farmers, or the wider elements of society and those friends of Kenya abroad who, over 21 years, have raised over Kshs 750 million to see the fruition of this project.”

“At this time of severe drought and considerable turbulence over indigenous forest conservation in the 4000 sq km Mau forest, the Rhino Ark fence is a beacon of hope and a proven management tool to ensure the Aberdares’ 2000 sq kms of vital water catchment, precious indigenous forest and irreplaceable flora and fauna are better secured. The project is a blue print for other threatened forest ecosystems in Kenya and the wider Eastern Africa and tropical Africa regions”, said Mr Church.

Its secret of success has always been that forest edge farmers have welcomed the fence since it has resolved human-wildlife conflict on a grand scale. In turn as full crop off-take is secured and land values have risen, the fence line farmers have turned to become the guardians of the indigenous forest inside the fence. They are now playing a key part monitoring the fence, reporting illegal and corrupt activities, planting indigenous trees inside the fence, developing forms of sustainable activity on their shambas and providing trained fence scouts who daily patrol the fence and help manage it.

Mr Church made special reference to the founder of Rhino Ark, the late Mr Ken Kuhle and the early supporters of Rhino Ark whose determination in the face of impossible odds started Rhino Ark as a fund raise and fence management mechanism.

The first Kshs 250,000 was raised from their brainchild - the Rhino Charge. This enabled the fence project to start. Today Rhino Charge – a world unique off-road event – raises over Kshs 60 million (about USD 1 million) annually. Rhino Ark attracts considerable further support from corporate and bilateral grants annually too.

During the past three years realisation of the benefit of the fence as a management tool for Kenya Wildlife Service and Kenya Forest Service has convinced the Kenyan Treasury to invest in the fence as well. To date over Kshs 112 million has been provided for wire and posts via KWS and KFS.

Amongst the forest edge farmers at the ceremony were groups from Gatamayiu, Kekika (Keraita/Kieni/Kamae) and Kipipiri - all of whom have won the prestigious Michael Werikhe Award for services to conservation in the Aberdare ecosystem. The award is

donated by the East African Wildlife Society and selected by the Rhino Charge Committee annually.

Elephants have ranged through forest land that links the two mountains for centuries. KFS, KWS and Rhino Ark reached a comprehensive agreement on the corridor alignment last month enabling the final 13 kms of the entire fence project to be completed before the end of August, 2009. It is the first such elephant corridor linking the Aberdares with a neighbouring elephant range area.

Rhino Ark’s project has created the largest wildlife fence successfully resolving human wildlife conflict in Eastern Africa. It contains 8000 kms of wire – sufficient to stretch from Nairobi to London – and 100,000 posts of which 20,000 are made from plastic waste.

“START OF SOMETHING EVEN BIGGER” – MINISTER WEKESA

“We cannot truly celebrate what has been done without recognising that the Aberdares is only one of six vital water towers in Kenya, and the biggest of them all - the Mau - remains in desperate peril. Kenya’s future environment is not assured until all of its forests are safe. Though there are considerable achievements that come with the completion, fencing Aberdares, it is not enough. The Aberdare Model should be used as a template to save and secure all other major forests.

The time to rise up beyond ourselves is now. The time to stand for what is right is now. The time to change our actions is now... while we have the opportunity to salvage our environment. We cannot go on talking forever, even when we have tasted the repercussions of our actions! We should learn from this experience that great risks are ahead of us if we do not do our part in conserving our natural resources.

Let today be the end of something big and the start of something even bigger.”

Along its entire length, forest edge farmers have participated in its construction and maintenance. Every 8 kms of the fence is daily patrolled by fence scouts employed from the forest edge communities.

The Aberdare fence is in reality now a public/private venture and as such ensures that all who need its benefits are responsible for its long term management.

The Kenya Government has started to endorse the principle of shared investment by committing the Kshs 112 million to the project to date. The principle of ‘a shilling for a shilling’ to ensure shared fiscal responsibility from both civil society taxpayers and the Treasury is taking root.

The formation of a trust with a mandate to manage the fence technically and to play an active role in the Aberdares’ ecosystem management generally is in preparation. It will bring this project to sustainability under a legally binding statute.

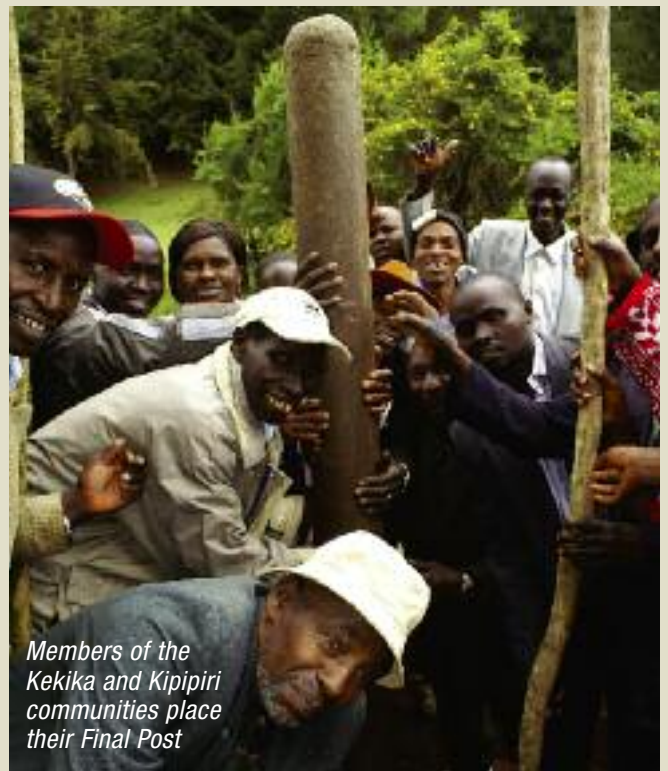

RETURN THE BUSH

RESTORING THE ABERDARE FOREST ONE TREE AT A TIME

Aberdare Range is located in the Central Province of Kenya. The Aberdare Conservation Area (ACA) comprises of Aberdare National Park (774 km²) and three Aberdare Forest Reserves (1,411 km²) the Aberdares, Kikuyu Escarpment and Kipipiri. The Aberdare Range constitutes one of the main water catchments area and is Kenya's largest area of heavy rainfall. Most of the water supplies;

1. Nairobi and the surrounding districts with population of over seven million people.
2. Kenya's hydro-electric power sourced on the Tana River which relies on Aberdare Range.
3. Agriculture (tea, coffee, floriculture, horticulture, dairy & staple food activities) within Rift Valley.

Aberdare Safari Hotels embarked on an initiative dubbed "Return the Bush". The initiative involved the rehabilitation of the salient area which is (152km²) 125 Ha of the Aberdare National Park. An area that has been degraded by the toll, the fenced-in elephant population has exerted on the ecosystem.

The project 1st phase span is 5 years and was started in 2007 with 1.5 Km fence. ASH financed planting of 19800 tree's covering 10Ha. Construction of 1.9M tall and 6-strand fence cost Kshs. 2.4 million. The project is to complete 10-15 Ha per year starting around the lodge thereafter embark on the rest of the Salient.

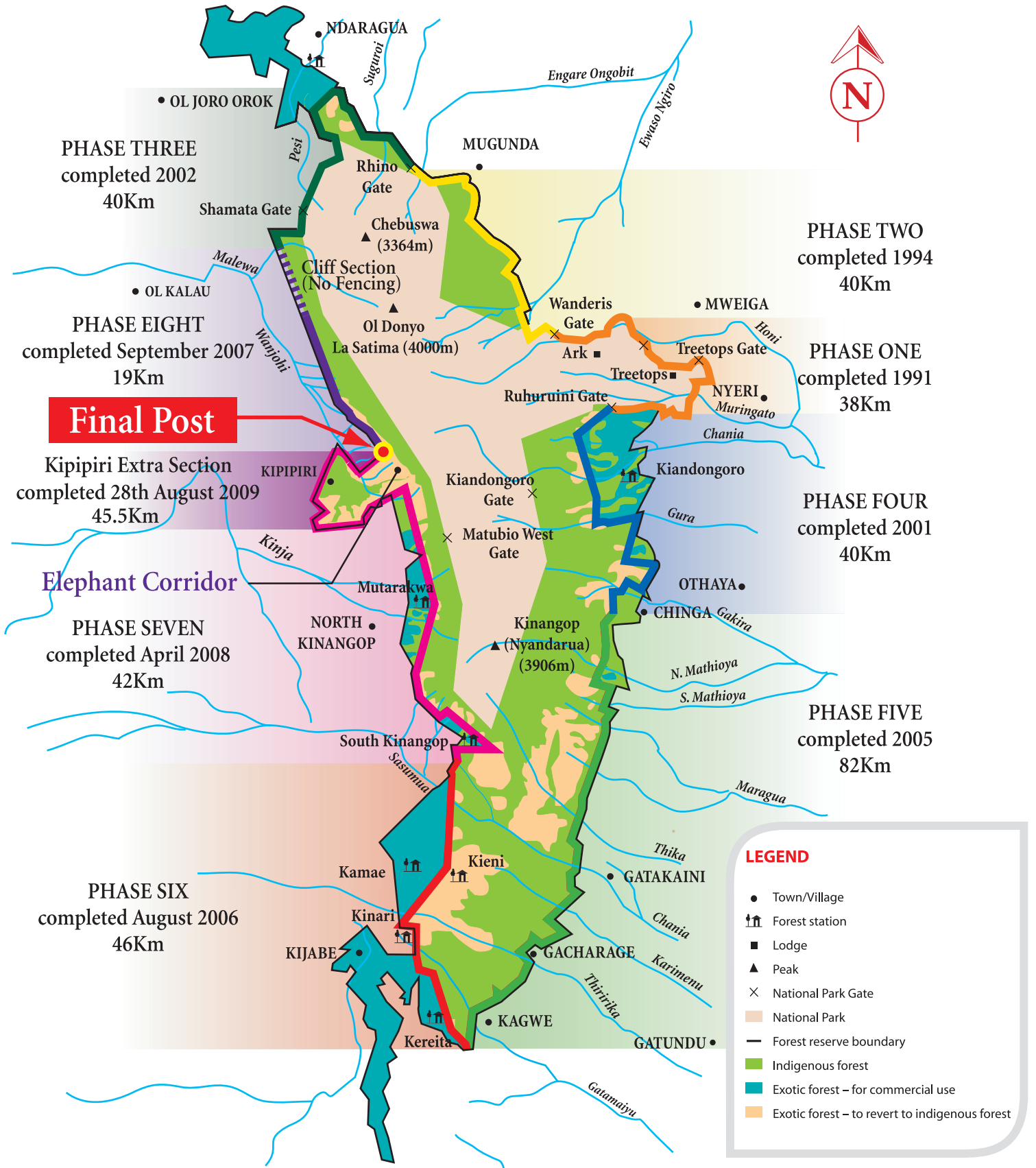
So far Aberdare Safari Hotels has facilitated planting of 27,200 indigenous trees in paddocks around Treetops in Aberdare National Park. Currently our tree nursery has 19 different indigenous trees of various heights and sizes, awaiting planting in the paddocks. Treetops is the world famous Tree Lodge where Princess Elizabeth first ascended with her husband on 5th February 1952 and descended the next morning as Queen Elizabeth II. Treetops is a property of Aberdare Safari Hotels.

Bees, snapped brake pipes, a wheezing fuel pump, giant wheel change, lost runners and minutes to spare.

Ben Woodhams of Car 39, fifth overall and third highest fund raiser tells his Mogoswok Charge story.

The 2009 Rhino Charge venue was a Sunday picnic drive - an easy four hours. Lots of time for an early pre-Charge day drive from Nairobi, with ample post-arrival time to check the car, do scrutineering and hand in all our money from the fundraising.

Mike DuToit, MD of CFC Stanbic Bank, had secured a large donation from the bank in exchange for the promise that the company's stickers would be prominent on the car. He is evidently a man of his word, as he proceeded to plaster the car in stickers. I managed to drag him off it when he started sticking them to the wheels! We decided that the car had contracted a new disease - CFC Stanbic pox.

At the Drivers Briefing, Clerk of the Course, Anton Levitan, reminded us that we should drive on the roads as little as possible,

before handing us over to the official doctor who warned us about a particularly nasty wild animal at large in the area - the African bee! We were deep in bee country, with honey a major export for the local community. Chargers were issued with a preventative antihistamine to take the night before.

As usual, supper that night was spent plotting the guard-posts on the map and trying to remember how to programme the GPSs. Once they were all plugged in, we did a round of GoTos to check. One of mine turned out to be over 9,000 kms away, which earned me much derision and abuse from the rest of the team.

A pre-dawn start saw us lined up behind the Clerk-of-the-Course Anton Levitan's car on our way to guard post **Pies-to-Go**. First disappointment: pies were not on the

breakfast menu! We resolved that we HAD to finish otherwise we would not get the chance to sample the piman's wares. We had decided to head to **Procraft** first. The access road to **Pies** lined up exactly with the route to **Procraft**! Under Anton's scornful eye we headed back down the road once the whistle was blown. I drove through a bush on the way out to try and make it more convincing, but I don't think Anton was fooled!

Once we broke off the road and headed through the bush, we tried to go as straight as possible - a route that would take us up a very steep hill almost immediately. I changed to low second, locked the diffs and headed up the hill, when the engine missed under high revs. Pre-Charge I had gone to endless trouble to identify the problem and we thought we had it solved. I couldn't believe that it had come back. It was to

plague us for the rest of the day. To make matters worse, a water pipe blew and sprayed boiling water through a hole in the bulkhead all over my legs. The jubilee clip was nowhere to be seen, so I had to make a bodge repair by twisting two lengths of fencing wire around the pipe with my Leatherman. After a rather hairy three-point turn, we headed back down the hill and around the brow on towards **Procraft**.

After a quick turn-around, we were on our way to **KWS**, which we did fairly straight. It was rocky and rough, but the huge ground clearance provided by our Unimog axles was making light work of the boulder fields. We met Patrick Garner (Car 49) and Ian Duncan (Car 2) at **KWS**, where Patrick told us that his new distributor had also failed. We had spent two hours fixing it. There is always someone with worse luck! One of Ian's team members pointed at our huge 'tackies'. A flat! We had to change that before continuing – no easy feat with those giant Unimog wheels!

My heart sank as we approached the Gauntlet to see a queue of cars waiting. That sinking feeling got worse when we were told that the car currently stuck had been there for over 45 minutes. We figured the quickest way through would be to get them through first. They were very stuck. Their short wheelbase Land Cruiser wedged on the rocks by its front and rear bumpers with its wheels spinning freely. They were trying to winch themselves free, but it wasn't working, so we got their hi-lift jack under their bull bar and jacked it into the air. We then pushed it off the jack, effectively moving the front of the car sideways by about a foot. We repeated this three more times and they were off the rocks and on their way. Another car was in front of us in the queue, and I asked if I could go in front of them, as I knew that we would have no trouble getting through. Sadly they declined, and we had to watch them struggle through for the next 45 minutes – they were eventually pulled free by the organiser's unimog. It took us about five minutes to drive through, and despite the crowd's cheering, I was feeling pretty sore about the delay.

The **Goodyear** control was manned by old friends. It was good to see them and cram down some boerewors before heading off to **Copy Cat**.

From there, we headed to **Vineyard Church** using the lugga which was surprisingly good going. At one stage we had to leave it as it turned into a narrow rocky gorge.

While we were waiting for our runners to find a way over the crest and back into the lugga, I decided to go for a small wander to sprinkle the bundu. A moment to relax. No way! One of the dreaded bees we had been warned about settled on my face and stung me on the forehead. It felt like the little bugger had injected its load of venom straight into my brain. Being a man, I dealt with the situation in the stoic manner to be expected – finishing what I had started out

to do! Then it was my moment to scream, and thrash about. Cor – our navigator with a steady hand, deftly removed the sting, and restrained me from calling in the chopper.

The drop back into the lugga, was treacherous and steep. Suddenly our steering dislocated as the full weight of the vehicle was pushing the rim of the front right wheel hard against a boulder and jamming it on full lock. A good deal of cursing and wheelspin in reverse and the car backed enough to straighten our wheels and head on down the slope. We had lost the line we had chosen and were forced to pass under a low tree that subsequently ripped the roof half off. Cor and I admired our new sunroof, but were not so impressed by the hailstorm of leaves, thorns and caterpillars we experienced for the rest of the day.



Our hosts at **Vineyard Church** were as hospitable as ever. We enjoyed the refreshments whilst trying to remember not to swear! **Vineyard Church to Land Rover** was a Tiger Line with endless gulleys and nasty little luggas. At one point we were traversing a side-slope, which with our ground clearance is always a hair-raising experience. I yelled for the 200kgs provided by Richard and Bernard on the running board to stop us rolling down the hill. As we crawled forwards, I looked down the hill, only to see one of the Unimogs at the bottom looking very bent and sorry for itself!

Mindful of the hour that we had lost in the Gauntlet, we roaded from **Land Rover to Hardi** only to find our car would not engage high ratio. We crawled undignifyingly along the road in low 5th! **Hardi** attacked us with their ice filled **Hardi** knapsack sprayer. Instant brain freeze, and their delicious ice creams. We always try to plan our route so that we get to **Hardi** at the hottest time of the day, when the ice creams really boost morale!

From **Hardi**, we headed back south along a huge wide sandy lugga. The going was good, At last our engine temperature fell below 38°C (100°F) for the first time since mid morning. We held onto the lugga for as long as we could and squared into the access road - the road heading up to **Brookhouse**. Only two guard posts left and just over an hour and to go!

At **Satao** we were behind another Unimog that was preparing to winch up a lugga out of the control. We were pretty desperate for time at this stage as it was 4:45pm and we only had 45 minutes to go, with the next stage being a Tiger Line into the final control. We chanced to take the lugga once again towards **Pies-to-Go**. We had to finish, at all costs, so we went for it. This was a bit of a gamble, especially as we had to winch ourselves up the hill at one stage.

The clock was ticking. Our engine problem was also getting really bad, with a constant misfire plaguing us. We had winched to the brow of the hill, and were following a single track through very dense terrain. We started going faster and faster with 20 minutes to go, following Mike DuToit, when we realised that we had lost our three other runners. They had GPS's so we figured they could walk into the final control, and we pressed on to try and get the car in by the 5:30pm deadline. As the terrain opened out, Mike climbed into the back of the car to direct us from his higher vantage point. I could tell that one of my break pipes had been torn off underneath, as the car lurched to the right every time I braked and after a short while pressing the brake pedal got no response whatsoever. I decided to keep this latest development to myself as we pressed on, crashing through the bush and over boulders in a desperate bid to finish.

A nasty lugga hove into view and Mike yelled from the back: "Stop. Stop! STOP!!"



I had no brakes at all, and we had no choice but to drop into the lugga with a sickening crash into the rocks as Mike leapt clear. "That's it then." said Cor, to which Mike replied, "You'll never get out of there." while he dusted himself down. I restarted the engine, selected low first, locked all the differentials, and gave her all she had left! The huge wheelspan found purchase, ripped the bulbar off the face of the rock and climbed up. The fuel tank guard crashed into the rock at the back, and with a grinding of metal against rock, blue smoke off the tyres, she was out! Mike's face was a picture, but we didn't have time to congratulate ourselves. We were off!

The access road into **Pies-to-Go** was in sight, when the engine died. I tried and tried to restart it, but it just wouldn't go. I couldn't believe it, so close and yet so far. "Just get it to the road, somehow!" said Cor, and as I frantically pumped the accelerator whilst holding my thumb on the starter, one of the eight cylinders began to rhythmically fire. A second fired, and once the third joined in I thought "That'll do" and let the clutch out, back in low first. She crawled forward, at less than walking pace, with a cylinder joining in the chorus every hundred yards or so. We made it to the road, and turned left in towards **Pies-to-Go**, by this time with all eight cylinders firing. As we picked up speed, our spirits rose, and we came flying around a blind bend to reveal a steep drop in the road. It was at this point that I remembered the lack of brakes. I flicked the gear lever from

5th to third, and we managed to slow down just enough to stay on the road. We careered into **Pies-to-Go**, with everyone cheering and shouting; and I took the car round in circles until I had bled off enough speed to stop. They must have thought we were doing victory laps!

A finish to cheer

Our support team was there to meet us, and we had a celebratory beer – we had finished with 5 minutes to spare, after having battled through the bush for ten hours! **Pies-to-Go** were delighted to get a car back to their control as we were the only team who made it back having started from there. I asked our fundi to see if he could figure out what was wrong with the engine. Head under bonnet he pointed at the fuel filter. It was completely dry. I then found that the switch to the fuel pumps was off. Must have been flicked down when we crashed into the lugga! I couldn't believe it, all that stress could have been removed with the simple flick of a switch! We had driven the last 15 minutes with no fuel pumps at all.

We also found that we had lost our tool kits – a disaster as they contained almost all the tools that I had been collecting over the last 20 years! Cor and Mike volunteered to go back to the lugga to retrieve the tools, and as they headed back down the access road they saw Bernard, Richard and Dirk carrying the tool box and tool roll down the road! They had decided to follow the trail of brake fluid we had kindly left for them

through the bush, rather than head directly to **Pies-to-Go**, reasoning that if we broke down they would find us.

Back at **Pies-to-Go** there was much derision and banter from the abandoned runners, but in reality everyone was delighted with the result and we celebrated with numerous pies washed down with cold Tusker.



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2009**

1. SIGNIFICANT ACCOUNTING POLICIES

- The principal accounting policies adopted in the preparation of these financial statements are set out below:
- (a) **Basis of preparation**
The financial statements summarise the transactions of the Trust and deal with the net assets at the disposal of the trustees. The financial statements are prepared under the historical cost basis of accounting.
- (b) **Income recognition**
Donations income is recognised when the monetary value of the donations can be measured with sufficient reliability, there is reasonable assurance of receipt and conditions for receipt, if any, have been met. Investment income is recognised on accrual basis.
- (c) **Property and equipment**
Items of property and equipment are stated at cost less accumulated depreciation. Depreciation is charged on the straight line basis over the estimated useful lives of the assets. The annual depreciation rates in use are:
Motor vehicles 25.0%
Furniture and fittings 12.5%
Computers 33.3%
Office equipment 12.5%
- (d) **Foreign currency transactions**
Transactions during the year are converted into Kenya Shillings at the rates ruling at the transaction dates. Assets and liabilities at the balance sheet date, which are expressed in foreign currencies, are translated at the rates ruling at that date. The resulting differences from conversion and translation are dealt with in the income and expenditure account.
- (e) **Financial instruments**
A financial instrument is a contract that gives rise to both a financial asset of one enterprise and a financial liability of another enterprise. The financial instruments held by the Trust are investments in the money market, trade and other receivables, bank balances and cash and trade and other payables. All the financial instruments held by the Trust are accounted for on amortised cost basis.
- (f) **Receivables**
Receivables are stated at nominal value, less provision for any amounts considered irrecoverable.
- (g) **Cash and cash equivalents**
Cash and cash equivalents comprise cash at bank and in hand and short term deposits with an original maturity of three months or less.
- (h) **Use of estimates**
The preparation of financial statements requires that the management makes estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates. The more significant estimation process is related to the determination of provision for doubtful debts. Although some variability is inherent in these estimates, management believes that the amounts provided are adequate.

Another Record Year

The total funds raised during the financial year under review was KShs 111 million.

The million dollar barrier was once again breached by Rhino Charge for the second year running despite the hard times – first post-election and then the credit crunch.

The 2008 Rhino Charge raised a final audited figure of KShs 63,638,135.

Gross donations amounted to KShs 81.1 million.

For the third year running the Kenya Treasury was our second largest donor providing KShs 30 million, for fence materials and channelled through our fence construction partners, the Kenya Wildlife Service.

Corporate/Conservation Bodies Support

Corporate and bi-lateral grant supporters continued positively. I would like to record special gratitude to Aggreko, the national grid power supply company that responded to our appeal to support the construction of energizer houses/guard posts by donating KShs 4,218,167.

I would also like to thank the following organisations who have made sizeable contributions:-

- Safaricom Foundation for the Elephant Grid requirements;
- Express Automation for donating two-way Motorola radios to Rhino Ark for use in all future Rhino Charge events;
- KPLC; and
- CMC.

Guard Post Construction

A total of KShs 10,262,151 has been spent on the construction of four guard posts in this financial year.

Fence Scout Training and Housing Improvements

In addition to the investment needed for permanent stone housing facilities built to KWS latest specifications, we have started an upgrade of all the temporary structures that await funds for upgrade to permanent.

We also undertook our first fence scout training programme for 25 scouts this year.

Fence Completion

We are in the process of completing the fence building. Mobilisation for fencing the Kipipiri extra section of 45.5 kilometres began in May 2008. There were protracted discussions between Kenya Forest Service, Kenya Wildlife Service and Rhino Ark relating to alignment issues including the width of the elephant corridor section that links Mt Kipipiri with the main Aberdare range – a short distance of about 4 kilometres. Rhino Ark provided the funds for the entire re-survey of the forest boundary of Mount Kipipiri undertaken by the Kenya Forest Service surveyors.

We also funded the elephant corridor professional study which made the final recommendations as to the width and alignment of the corridor. The corridor has a funnel system at both ends. Its narrowest point is 700 meters wide. Construction began in October 2008. As of 31st March 2009, the 19 kilometres remaining required the corridor issues to be resolved. Completion schedule of the fence has delayed the work considerably.

The Future of the Trust

As we look to the future, and the establishment of a Trust to manage the fence as a key component in ecosystem management in the Aberdares, we do call for continued Government support and for the gazette-ment of such a Trust, thus forming a legal institution for posterity.

A document entitled “*Aberdare Fence Management Strategic Plan*” was completed in March 2008. It encapsulates the thinking and detailed financial proposals by the Kenya Forest Service, the Kenya Wildlife Service and Rhino Ark. It proposes representation on the Trust of forest edge communities and representation from the Aberdare fence line communities.

Rhino Ark's efforts represent civil society commitment to conservation in the Aberdares. But as partners with Government, the fund levels need to match those that have been raised principally from Kenyan tax payers over nearly twenty years since Rhino Ark was established.

The General Fund

The general fund as reflected in the balance sheet has been split into two categories namely; Fence Maintenance Reserve and Fence Construction Reserve. Twenty percent of each year's Rhino Charge donation is allocated specifically for maintenance of the fence already constructed. This is to ensure that the huge amount of effort and money put into the conservation programme does not collapse from lack of maintenance. The maintenance reserve is therefore to earmark these funds for maintenance and not used for construction.

The fence construction reserve deficit had increased during the year from KShs 6 million to KShs 14.9 million. This situation is expected to reverse during the current financial year.

Bongo Surveillance Programme successes

This endangered species initiative which started in the Aberdares and has now confirmed other highly threatened groups of bongo in Mt Kenya, the Mau, and Mt Eburru has continued to receive our support particularly for the anchor herds – the largest of all so far identified that inhabit and roam the forests of the Aberdares. The UNDP provided Rhino Ark with a USD 50,000 grant under its Small Grants Programme, to support our efforts in both the Aberdares and Mt Kenya. This two year programme will end in 2009. We are actively seeking further funding sources to continue the programme.

The importance of this effort is to highlight to the communities that such endangered animals will be lost if the forest is not conserved. A significant element in the UNDP programme is directed at a schools' awareness campaign.

Mountains dry, animals die – *By Colin Church*

Droughts happen. Droughts are nature's way of asserting itself. Droughts alert us to Mother Nature's strength over the environment.

And droughts can be followed by floods.

At such stress moments in nature's cycle, we mere mortals have a brief moment of opportunity to take stock of the precarious state of the precious resources at our disposal. We have a chance to take actions which can mitigate against the massive forces that shape our natural world.

Tana. At Ndakaini the benefits of a stable forest belt and improving tree and vegetation cover on adjacent farm land are clearly demonstrated.

Two major factors have impacted upon the wildlife – naturally the drought itself, but also human pressure to exploit at a time of crisis. Bush meat hunting has accelerated. The Bongo Surveillance Project teams, with KWS support, retrieved 41 heavy wire snares and destroyed six spike pits in areas of northern Aberdares on a single sortie. Elephant have been targets. The

Pre-October rains – Nairobi's main water source Ndakaini dam was 14.5 metres below optimum level

Large parts of the East Africa region have just experienced perhaps the worst drought since the 1959/60 devastation – sixty years ago.

In the Aberdares a heavy toll has been exacted on the wildlife and flora during this near two year spell of below normal rains.

On the eve of the 'short' rains I journeyed over the southern Aberdares (Oct 8) where normal average annual rainfall is in the 2000 – 3000 mm range and as the rains broke on October 14th over the moorland and through the lower wildlife rich Salient where rainfall ranges between 1200 and 2000 mm.

The severity of the conditions was best expressed by the water level in the Ndakaini Dam where the line was 40 feet (14.5 meters) below the high water mark. Ndakaini is fed by several streams and rivers sited only 7 kms from the Fence.

Red soil runoffs from the un-terraced lower hillsides of Mt Kenya and the Aberdares have drastically affected silt levels in the big hydro power water storages of the

Cites partial lifting of the ban on Southern Africa ivory sales has impacted more than at any time since the Ivory Burning in July 1989 twenty years ago. The 'China presence' in all regions and certainly around the Aberdares where some major road construction is in progress has stoked the situation.

In October KWS successfully arrested a lorry load of cut cedar near Embaringo in Northern Aberdares. (*See picture above*)

In the Salient the large herds of buffalo had migrated. As many as 70% of the resident animals had gone in search of better conditions in the high bamboo belt above 9000 metres. During these past dry months the elephant herds remained in the wetter Southern forests, the upper moorland and bamboo belts, avoiding the popular Salient and lower slopes of Northern Aberdares.

Most ungulate feeders that remained in the Salient were in poor condition by the time the rains broke on 14 October. The heaviest toll was taken by Giant Forest Hog, principally a night feeder. I counted 48 of these huge beasts feeding in broad

daylight on what little green shoots they could find along the roads and tracks of the Salient. Many have died of starvation and the ones I saw were skin and bone. One had been dead for two days and with no scavenger evidence. The hyena population had followed the buffalo into the higher areas.

In the South near Njabini a pack of wild dog had found a way out of the fence – most likely at a stream crossing or an open gate – and devastated a herd of sheep owned by a fence line farmer.

Quite out of its range, a single Secretary Bird has taken up residence in the moorland likely lifted there by a dry weather wind thermal. It has to restrict its food search to the roads and tracks as his striding legs cause him to stumble in the giant tufts of moorland grass.

A male Bongo was seen by honorary warden Johnny Baxendale in the upper Chania valley in the moorland.

The conditions changed dramatically with the onset of the rains. Will we humans take sufficient stock? Only time will tell.

Elephant corridor complete – an ecosystem first

Resolution of alignment issues that focused on the elephant / wildlife corridor between Mt Kipipiri and the main Aberdares range was essential prior to completion of the entire fence.

KFS, KWS, the fence edge communities in the area and Rhino Ark were able to reach an agreement after protracted discussions took place to resolve the core issues.

Certain aspects were not in dispute. The principal of the need for a corridor had been reached in 2008. The fence line edge communities were in full agreement that a corridor should form part of the overall environment plan for the Kipipiri/Satima land linking the two at Geta. The KFS challenged the expert's proposal for optimum width of the corridor as recommended by the wildlife consultant commissioned by RA/KWS and KFS.

Final agreement was reached in July 2009 whereby the funnels into the corridor are within the parameters of the professional view but in one very short stretch a width of 700 meters was finally agreed. The average width into the final funnel areas from the west and eastern approaches is about 900 meters. Thus areas of exotic softwood timber plantations remain outside the fence on each side acting as buffers and retained for soft wood re-plant.

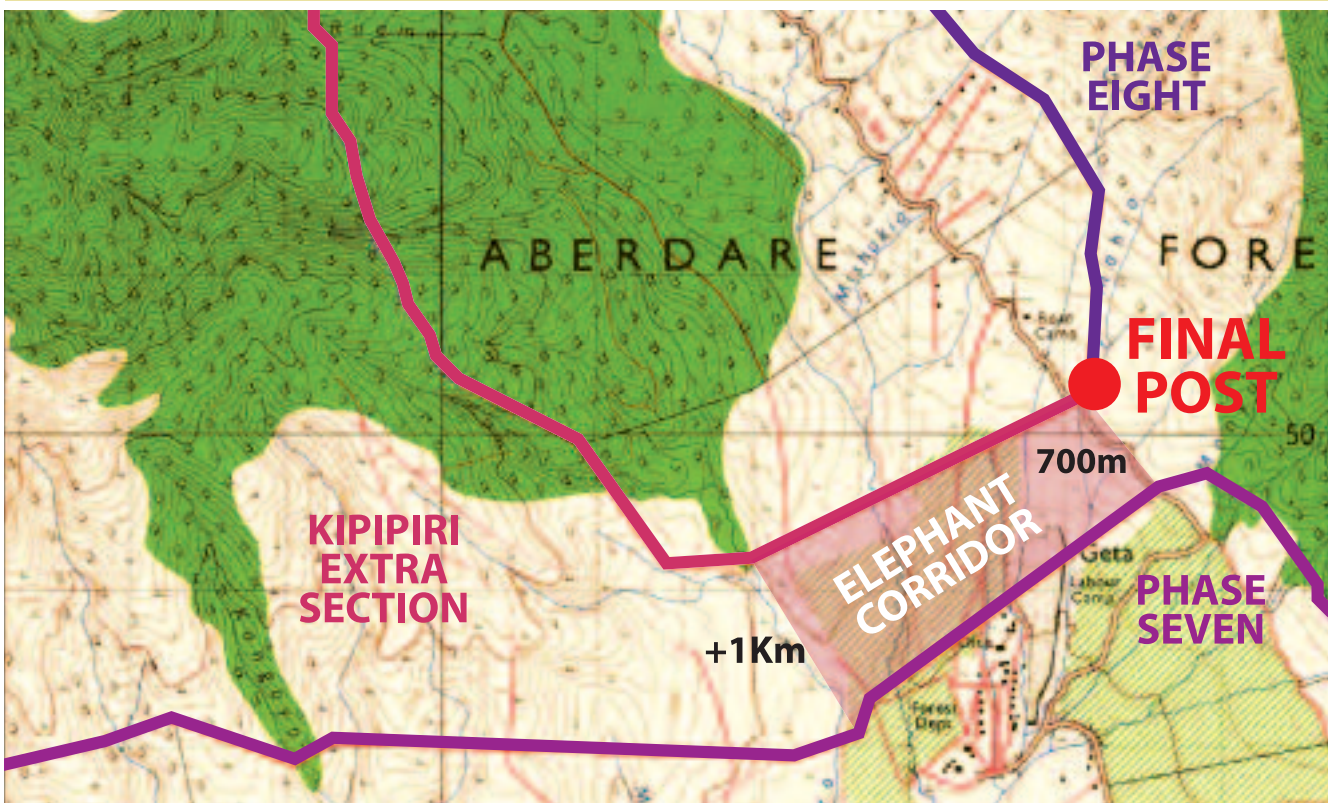
The 7.5 and 5.5 kms borders of the corridor were the final sec-



tion of the great Aberdare fence to be constructed. Inside the corridor the policy of indigenous tree re-stocking will apply and local communities will play a part in this exercise.

The Kipipiri corridor is the first formal wildlife dispersal to be installed within the greater Mountains Conservation Area of Aberdares and Mt Kenya. It is Rhino Ark policy to develop further such dispersals linking the Mountains with Laikipia and

Bongo Conservation – Aberdare School Sets the Pace *By Eric Kihiu*

In 2007, the Rhino Ark supported Bongo Surveillance Programme (BSP) established a schools' wildlife clubs initiative which aimed to propagate conservation awareness and practice amongst local communities. It is funded by grants from donors, key among which have been UNDP's GEF / Small Grants Programme and Tusk Trust.

Under the programme, a schools wildlife clubs coordinator was engaged to run the initiative and recruit member schools in areas where the endangered Eastern Mountain Bongo are found, mainly Aberdares and Mt. Kenya. The coordinator, Peter Munene, has since founded clubs in six schools which take part in activities such as:

- Educational trips to national parks and wildlife conservancies
- Wildlife essay writing and drawing competitions
- Tree planting
- Classroom instruction on conservation

Under this programme, Rhino Ark has developed bongo educational materials. 1,000 brochures and 56 large format posters have been produced and distributed to schools and community centres to enhance the pupils' knowledge about the mountain bongo.

Among the beneficiaries of this programme is Kamburaini Primary, a 200 pupil strong rural school at the foothills of the northern Aberdares.

Recently, representatives from Rhino Ark, Kenya Wildlife Service and UNDP jointly paid a visit to the school to assess the progress of the wildlife clubs initiative. They were warmly received by the headmaster, teachers, pupils and their parents. In the colourful event, conservation poems, songs and dances were performed by school pupils.

A tour of the school followed and Headmaster Stephen Muthigani presented the various conservation initiatives in the school:

- 240 indigenous trees were planted in the school grounds by the pupils in 2008, and they continue to tend to them

- A 'bongo roundabout' has been built on which the pupils have made a bongo sculpture of wood and cement
- An indigenous tree nursery has been established. The seedlings will be made available to the local communities for planting on their own land

From the tour it was clear that conservation values have penetrated deeply into the consciousness of the community. The educational materials produced have been particularly effective. Indeed, a local bar owner was so inspired by the bongo poster that he borrowed one from the school and displays it in his bar to educate patrons.

The formal instruction part of the schools wildlife club's curriculum has also boosted the academic performance of the pupils.

"After one year being a member of the wildlife club, I have learnt a lot. This has helped me perform well in Agriculture, Science and Social Studies. The wildlife classes are fun and practical," says Consolata Kanini, a class 8 pupil at the school.

The success of this programme has been an inspiration to many. Rhino Ark is committed to ensuring its continuity. The funding under the UNDP grant ends this year, further support from donors is needed to keep it running smoothly.

Rhino Charger exemplary MIKE HIGGINS



Michael ("Mike") Higgins, Trustee since 2002 and who was involved with Rhino Ark from its inception in 1988, died on September 17th, 2009 in the Intensive Care Unit of Nairobi Hospital. Mike had been admitted to the ICU only the day before and his death was very sudden. He was aged 79.

Since 1991, Mike and his devoted wife Sarah competed in the Rhino Charge driving an old farm Lada Niva. For more than 17 years, Mike and Sarah collected a total of Kshs 39,607,239.70. They retired from Charging in 2008 and until the 2005 Charge, held the record for the most money raised for Rhino Ark.

Year after year they carried off the David Schaeffer trophy awarded for the highest amount collected in fund raising. They won the Rob Combes Memorial Award for the 'Spirit of the Event' in 2000.

A man of quiet persuasion, hugely warm hearted and always generous, Mike could be relied upon as a Trustee at testing times when wise council was required.

Prior to becoming a Trustee, Mike offered to take on the making of plastic posts from flower farm plastic waste when the late Ken Kuhle, former Rhino Ark Chairman, found a unit in England that would do the job. Mike's hugely patient approach to coaxing the best out of 25 year old machinery delivered huge dividends. The project continued to grow from strength to strength. Some 20,000 of the 100,000 posts used on the fence line were extruded on Mike's farm – all of the work done voluntarily on a not-for-profit basis for Rhino Ark.

The project began to churn out 4 inch diameter posts in 2000. In 2002 the provider of the first unit, Keith Bamforth and his Birmingham Company Kween Bee, then found and donated a second much bigger unit – "built like a tank", Mike used to say, and which makes 6 inch diameter posts.

Mike grew up under the shadow of the Aberdare Mountains where his father Rex was an equally skilled and committed farmer. His understanding of the vital role the Aberdares plays in the life of the millions who live within its shadow was always paramount.

Rhino Ark owes a great deal of thanks and appreciation to Mike - a man of great heart and goodwill.

UNEP support for Ecosystem Review

The United Nations Environment Programme (UNEP) is providing Rhino Ark with USD 31,000 to support an assessment of the fence's impact upon the stability, security and integrity of the Aberdare Conservation Area (ACA).

The East African Wildlife Society's Kenya Forest Group are lead partners and will act as secretaries to the working group which has been formed and which consists of UNEP, KFWG, Rhino Ark, KWS, KFS and the Greenbelt Movement.

The environmental assessment will review the environmental, social and economic impacts of the Aberdare fence – now complete and just under 400 kms long, encompassing 2000 km² of indigenous forest and mountain upland.

The assessment has two objectives:

- To carry out an assessment of the fencing of the Aberdare Conservation Area in order to guide its future management;
- To provide an in-depth review of fencing as a tool to sustainably manage a conservation area.

Rhino Ark has maintained a policy of objective assessment of its mission in the Aberdares from its early beginnings 20 years ago. In 1999, Rhino Ark initiated and secured funding for what is commonly called the Butynski Report- an in depth professional document which after stage by stage *barazas* with forest edge communities and taking a scientific and pragmatic approach to terrain secured the alignment for the fence and confirmed that fencing was the best option for resolving human/wildlife conflict and forest integrity for the Aberdares.

Then in 2003 Rhino Ark initiated an Aerial Survey of the Aberdares – again with UNEP, KFG and KWS participation and which was able to confirm a dramatic reduction in forest destruction through illegal logging and charcoal offtake inside the 120 kms of fencing completed at that time.

This year's UK Rhino Charge raised £9,035.73, a brave effort by the 13 teams involved in the current climate and especially welcome for Rhino Ark, the Kenyan charity which has just completed a 400 km fence to protect the Aberdares National Park and safeguard it for future generations. In a time of severe drought, looking after the water catchment area of the Aberdares is even more vital than normal.

Newcomers Team Dirty Berty led by James Dodson, came first overall with 777 points scored out of a possible 850 and also took the Tiger Lines Trophy – a great family and friends team effort in a neatly prepared vehicle. The team hope to ship their Range Rover based special out to Kenya to do the Rhino Charge there soon. Second was the rorty Toyota Landcruiser FJ40/VX hybrid of Rashminder Bhabra on 723 points. They were pushing for glory in the voluntary and tougher Tiger Lines until a CV joint exploded on the final section – who said Toyota axles never break?

Veteran fund raiser Kit Kaberry was given the humorous 'Where the F*** Are We?' prize for generally ignoring his navigator and going backwards when he should have been going forwards. However, and much more importantly, he also achieved the highest funds raised overall and won the Victor Ludorum Trophy for the best combined performance in the Charge and sponsorship raised, meaning that he is given the opportunity to use a loan car provided by KVM in Kenya in the 2010 Rhino Charge, subject to bringing sufficient sponsorship along.

Pritam Choda won the Spirit of the Event award for consistently giving the lie to his age by driving like a lunatic teenager, demolishing section markers with great enthusiasm and never giving up, even when his supply of suitable tyres to borrow ran out!

This year more emphasis was put on the special tasks and varied trials sections and less on navigation, which seemed to make for a more relaxed event. One competitor remarked that the Rhino Charge was the most enjoyable day's competition he had ever done and everyone went home with a smile on their faces.

Thanks are due as always to the competitors and their many and varied sponsors, to Brian Hartley and his Red Coats of Club Off Road for looking after the competition side of things and to Huw Wright and the South Coast Land Rover Club members who ran the spectator convoy and radio communications.

Barrier relief

John visited the Aberdares in May 2009. Herewith excerpts of his article published on May 13, 2009

In a few months time, the labours of the group, Rhino Ark, will be largely over. The seven-strand, eight foot high electric fence will be finished, but it is nothing like what was envisaged in 1989. Instead of being just a few kilometers long, it encircles the whole Aberdare mountain range, which includes some of Africa's most rugged landscapes and spectacular forests. What is possibly the longest conservation fence in the world stretches up and down hills with a 1 in 2 gradient, passes over rivers, and along the edge of hundreds of communities. It will be 250 miles (400km) long, enclose nearly 2000 sq km (772 sq miles), has needed nearly 6,000km of wire and the cost will be more than \$8m (£5.3m). Almost certainly, it will become a blueprint for other parks in Africa.

"It just grew and grew," says Colin Church, Chair of Rhino Ark. "in the early days, the motivation was to protect the black rhino, but then we all woke up to the fact that the farmers (who lived near the fence) were celebrating and the reality that this forested mountain area was the livelihood for millions of people. We realized the whole ecosystem was at stake."


Increased human poverty, climate change, a burgeoning population of several million people around the park and greater

demand for wood and water in Kenya have all led to new pressure on the Aberdares. At stake now is not just the rhino, say scientists, politicians and conservationists, but Kenya itself.

"It is vital for communities," says Wangari Maathai, the Nobel prize winning environmentalist, whose family's home at Ithite is just two miles from the eastern line of the fence. "it works well. People want to go to the forest because they can grow food, but they do not realize they undermine the future of all Kenya."

Because of the fence, both Rhino Ark and the KWS have started to see conservation and the role of the protected areas differently. Instead of the old conservation model of just trying to keep people out of parks, there is wider recognition that the forests and water sources need people to protect them. The way to do that is to allow people to benefit, and the two groups have started more than 50 projects to improve village water supplies and set up tree nurseries to help people grow their own firewood.


"Once it was important for animals. Now it is seen as critical for humans too," says Church.
