



***Community Development Financial Institution Assistance Program***

Community Development Financial Institutions (“CDFI”) provide micro-loans to businesses who often do not qualify for bank loans as well as one-on-one counseling and business development assistance to facilitate credit-readiness. Every year these CDFI’s help thousands of small and micro businesses survive and flourish in New York State.

Since 1997 ESD has awarded \$17,216,193 in grants to federally-certified Community Development Financial Institutions (“CDFI”) to assist in their efforts to develop minority and women-owned business enterprises and small businesses. This year ESD awarded \$2.99 million in grants to 28 across New York State. The organizations use these grant funds expressly to strengthen their lending and technical assistance services.
