Kit Carson County Commissioners,

I am requesting that you allow me to continue paying out overtime hours instead of giving comp time. With the landfill be open 5 ½ days a week, there are two individuals that end up with a least 4 hours of overtime a week. That is 6 hours of comp time per individual per week or 12 hours for the two. It is set up that an individual works two weekends and then is off the next weekend. This means that two individuals may end the month with up to 18 hours or more of comp time per month and one may end up with 12 hours. That would be 72 days a year plus vacation days (47.63) and sick days (?) that are used, someone would be gone from work. Out of approximately 248 work days in the year, 120 days a year I would be short 1 employee from a 3 person crew. By paying out the overtime, it takes care of those 72 days away from work.
