DUTY ROSTER FOR PLEA BARGAINING FOR THE MONTH OF DECEMBER-2015.



They will deal with the applications filed under chapter 21A Cr. P. C . on aforesaid working days.

03. All the Metropolitan Magistrates are directed not to deal the cases of the Police Station which they are dealing in their regular Courts, in Plea Bargaining Court. If any case is listed before the MMs of such Police Station, the same be put up before Sh. Vinod Kumar Gautam, ACMM-2, for further marking.
04. All the summons/notices in respect of Plea Bargaining Applications shall be issued by the Ahlmad of the court of concerned Plea Bargaining Judge, till further orders.
