





"Out of my window, I could see young children, abandoned, involved with drugs and misery. I started wondering how I could help them. At first, it was a group of teenagers. I approached them and asked them to play basketball. Now (2016), 500 children of all ages come to the Ark". "Our door will always be open for them". The offerings of the people started coming after a while, when they got to know the young priest "Father Antonios" who founded the Ark of the World and realized his intentions. The residents of the area started coming one after the other and volunteered their services. Teachers started giving lessons to the children, housewives from the area started bringing things from their homes, food and clothes that their families no longer needed. Thus, with the help of volunteers, the Ark of the World was created, an organization aiming to pull as many children as possible away from poverty and abandonment and offer them a chance to stand on their own two feet.

Nowadays, the organization provides Schools for Parents, Personal meetings with families in need, Psychological and Legal Support, Support in the form of food and clothing, medical and pharmaceutical care, educational programmes for vocational training. For the children in need, it is provided accommodation, foster and legal care, social and psychological support, entertaining activities.

The structures of the Ark have expanded to Piraeus, Ioannina, Chios, Volos.



The principles of the UN Convention on the Rights of Persons with disabilities constitute a suitable manifesto for the Federation and the associative network that recognizes and identifies FISH as their unified voice towards the main institutions of the country.

Through collaboration with the Italian Forum on Disability (FID), the body that represents Italy within the European Disability Forum (EDF), it connects the national policies with those at transnational level. E.net Agency is the statutory instrument which the Federation uses to design and manage their projects and initiatives, taking as reference the strategies developed by the FISH Board and acts according to the methods of work for the network and participatory planning. The Agency is made up of local groups, active in various regions, and a national coordination.

On October 26th 1920, the Italian Association for the Blind was born, as an extension of the Blind teachers' association, and its founder and first president was Aurelio Nicolodi. The birth of the Italian Association for the Blind marks the first step of a long path towards social integration.





























Shortly after the Association's inception, was established the Newspaper for the Blind, the National Library for the Blind, the Braille Print House, the National Labor Institute in Florence, Rome, Naples, and many other initiatives were announced.

In the Thirties, the progress has been very slow, and some objectives were thwarted by regime's corporate structure. However, there were two important breakthroughs: the abolition of the New Civil Code of the incapacitation of the blind from their birth and their inclusion into the Air Force as sound-locator operators.

Towards the end of WWII, Nicolodi, disliked by the regime, was removed from office and replaced with Paolo Bentivoglio who stayed on as president for almost twenty years, until 1965. It was a time of post-war reconstruction and there were some remarkable historical moments such as the big demonstration in Rome in 1954, the so-called "grief march" which led to a first legislation for a pension for the blind.

The current Italian Association for the Blind, headed by Tommaso Daniele, has to fight to defend the achievement reached so far and at the same time move painstakingly towards new objectives, which have to fit into the modern social reality. The Association has to take into account that young people might not feel such a strong allegiance to it, as others did in the past, that same spirit which took the association from its 8.000 members in 1947 to the nearly 120.000 as of today.
