6. TOURNAMENT DIRECTOR'S DECISION WILL BE FINAL IN ALL MATTERS.
7. FISH MUST BE ALIVE TO BE WEIGHED IN.
8. ONLY ONE BASS PER HOUR PER CONTESTANT.
9. WINNERS MAY TAKE MORE THAN ONE HOURLY BIG BASS, BUT ONLY ONE BIG BASS PER CONTESTANT FOR GRAND PRIZES.
10. TIES WILL SPLIT WINNINGS AND POSITION.
11. 12 INCH MINIMUM LENGTH.
12. NO ALCOHOLIC BEVERAGES ALLOWED.
13. LIFE JACKETS MUST BE WORN WHEN BIG ENGINE IS RUNNING.
14. ALL GRAND PRIZE WINNERS MIGHT BE SUBJECT TO A POLYGRAPH TEST.
