The undersigned is directed to refer to the Ministry of Railways (MoR) OM No. E(P&A)II-2017/HW-1 dated 9th September, 2021 and OM dated 4th March, 2022 regarding removal of ceiling in respect of Night Duty Allowance (NDA) for employees of the Railways.

- The proposal has been considered in this Department and it is agreed that:
  - NDA may be granted to all eligible non-gazetted employees of (i) Ministry of Railways upto Pay level - 7 (including those who are granted the benefit of MACP in Pay Level - 8). However, maximum Basic Pay for working out hourly rate of NDA shall remain ₹43600/i.e. the prescribed ceiling fixed by DoP&T vide OM dated 13th July. 2020.
  - It shall be admissible from the date of issue of the orders on the (ii)subject.
  - Other terms and conditions to grant NDA shall remain unchanged as (iii)issued vide DoP&T OM dated 13th July, 2020.
