



**2022 MR. LEGS TICKET GIVEAWAY  
OFFICIAL CONTEST RULES AND REGULATIONS**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPENING A NEW BANKPLUS ACCOUNT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Contest open only to legal residents of the United States who are twenty one (21) years of age or older at time of entry. Void where prohibited, taxed or restricted. **WHO CAN ENTER**
