### 1. PRECAUTIONARY MEASURES AGAINST THE CORONAVIRUS DISEASE ("COVID-19") AND MODE OF MEETING

- The Securities Commission Malaysia ("SC") had, on 16 July 2021, issued a revised Guidance and FAQs on the Conduct of General Meetings for Listed Issuers ("SC Guidance Note") whereby listed issuers are encouraged to continue leveraging technology in conducting general meetings beyond Movement Control Order.
- In line with the SC Guidance Note, the Company's 32<sup>nd</sup> AGM will be conducted entirely **through live streaming from the Broadcast Venue**.
- The **Broadcast Venue** of the 32<sup>nd</sup> AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue of the meeting together with the essential individuals as indicated in the SC Guidance Note. Shareholders/proxy(ies) from the public WILL NOT BE ALLOWED to be physically present at the Broadcast Venue on the day of the meeting.

### 2. SHAREHOLDERS' PARTICIPATION AT THE 32<sup>ND</sup> AGM VIA REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

- Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 32<sup>nd</sup> AGM using RPV facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor").
- The RPV facilities are available on Tricor's TIIH Online website at <u>https://tiih.online</u>.
- We **strongly encourage** you to participate the 32<sup>nd</sup> AGM via the RPV facilities. You may also consider appointing the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 32<sup>nd</sup> AGM.
- Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

### Note to users of the RPV facilities:

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

- Only members whose names appear on the Record of Depositors as at 13 May 2022 shall be eligible to participate in the 32<sup>nd</sup> AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the 32<sup>nd</sup> AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 32<sup>nd</sup> AGM yourself, please do not submit any Form of Proxy for the 32<sup>nd</sup> AGM. You will not be allowed to participate in the 32<sup>nd</sup> AGM together with a proxy appointed by you.

## 5. VOTING AT MEETING

- The voting at the 32<sup>nd</sup> AGM will be conducted on a poll pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"). The Company has appointed Tricor to conduct the poll voting electronically ("e-voting") via Tricor e-Vote application ("Tricor e-Vote App") and Scrutineer Solutions Sdn Bhd as Independent Scrutineers to verify the poll results.
- Shareholders can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and submit your votes at any time from the commencement of the 32<sup>nd</sup> AGM at 10.00 a.m. Kindly refer to "Procedures to Remote Participation and Voting via RPV Facilities" provided above for guidance on how to vote remotely via TIIH Online.
