


Figure 1. (Top) top view and (bottom) bottom view of the onsemi C-Series SMA boards, from left to right 6mm, 3mm and 1mm




Figure 2. Board schematics for the MicroFC-SMA-100XX




Figure 3. Board schematics for the MicroFC-SMA-300XX




Figure 4. Board schematics for the MicroFC-SMA-600XX




Figure 6. Board schematics for the MicroFC-SMTPA-100XX




Figure 7. Board schematics for the MicroFC-SMTPA-300XX




Figure 8. Board schematics for the MicroFC-SMTPA-600XX
