Announcement of Organizational and Personnel Changes

Tokyo Century Corporation (the "Company") announces the organizational and personnel changes as below.

1. Organizational Changes (as of April 1, 2023)

(1) Absorption-type merger of consolidated subsidiaries

The Company has absorbed its wholly owned consolidated subsidiaries TC Business Service Corporation and TC Business Experts Corporation.

(2) Changes in operating segment

- (a) To further expand environmental and energy-related businesses, Environmental Infrastructure will be established as an operating segment, which will be spun off from Specialty Financing.*
- (b) Mobility & Fleet Management will be renamed as Automobility.

* Given that decarbonization efforts, including in the power field, are required, the Company has strengthened and expanded environmental energy businesses, such as renewable energy, storage battery, and other sources in Japan and overseas. To strongly support the business strategies for achieving decarbonization of customers and partner companies, the Company decided to establish Environmental Infrastructure as an operating segment.

(3) Changes in Units

(a) Equipment Leasing Support Unit will be established within Equipment Leasing. The business support function for Equipment Leasing Business Development Unit, the business assistant function for each division of Equipment Leasing, and the function of TC Business Service Corporation will be transferred to Equipment Leasing Support Unit.

- (b) With the name change to Automobility, Mobility Business Development Unit will be renamed as Automobility Business Development Unit.
- (c) With the establishment of Environmental Infrastructure, Environmental Infrastructure Business Development Unit and Environmental Infrastructure Business Unit will be established.

(4) Changes in Divisions and Offices

- Operation Headquarters
 - (a) Secretariat of Corporate Planning Division within Corporate Planning Unit will be renamed as Secretarial Division.
 - (b) Investment Management Office of Credit Supervision Division III within Credit Supervision Unit will be renamed as Investment Management Division.

- (c) Corporate Business Division V within Corporate Business Unit I will be eliminated, and its function will be integrated into Corporate Business Division IV.
- (d) Business Advisory Division will be established within Equipment Leasing Support Unit.
- (e) Business Support Division I will be established within Equipment Leasing Support Unit.
- (f) Business Support Division II will be established within Equipment Leasing Support Unit.
- (g) Contract Administration Division within Equipment Leasing Business Development Unit will be eliminated, and its function will be transferred to Business Support Division I and Business support Division II.
- (h) Business Management Division within Corporate Business Unit I will be eliminated, and its function will be transferred to Business Advisory Division.

<Automobility>

- Mobility Business Strategic Planning Division within Mobility Business Development Unit will be renamed as Automobility Business Strategic Planning Division.
- (j) Next Generation Automobility Business Division will be established within Automobility Business Development Unit.

<Specialty Financing>

(k) Real Estate Business Management Division will be established within Specialty Finance Business Unit II.

<International Business>

(I) Global Business Management Division will be established within International Business Development Unit.

<Environmental Infrastructure>

- (m) Environmental Infrastructure Strategic Planning Division will be established within Environmental Infrastructure Business Development Unit.
- (n) Environment & Energy Business Division I within Specialty Finance Business Unit I will be renamed as Environmental Infrastructure Business Division I and transferred to Environmental Infrastructure Business Unit.
- (o) Environment & Energy Business Division II within Specialty Finance Business Unit I will be renamed as Environmental Infrastructure Business Division II and transferred to Environmental Infrastructure Business Unit.

- (p) Environment & Energy Business Division III within Specialty Finance Business Unit I will be renamed as Environmental Infrastructure Business Division III and transferred to Environmental Infrastructure Business Unit.
- (q) Environmental Infrastructure Business Division IV will be established within Environmental Infrastructure Business Unit.
