- Defence Counsel and the Prosecutor will receive a meeting invite from the Trial Coordinator to meet by audio conference or videoconferencing to canvass and select a date.

#### SETTING THE TRIAL DATE

- The trial / preliminary inquiry date selected using this form will be formally set at the accused person's next court appearance.
- The accused person must attend at that next court date if (i) Defence Counsel is not retained for the trial / preliminary inquiry, or (ii) the accused person is self-represented.
- If Defence Counsel is retained for the trial or preliminary inquiry, the date selected using this
  form will be formally set at the accused person's next court appearance without the accused
  person personally attending, in accordance with rule 4.5 of the Criminal Rules of the Ontario
  Court of Justice. If Defence Counsel chooses to do so, they may attend at the next court
  appearance to set the trial / preliminary inquiry date before the presiding judicial official.
