- a. 1 Bockland Close, Cullompton (20/02155/HOUSE). Erection of decking to include raising of garden level and erection of a retaining wall and fencing.

- b. 14 Exmoor Way, Cullompton (21/00060/HOUSE). Raising of ground levels in rear garden and erection of 1.8m screen fence.

- e. Hillersdon House, Cullompton (21/00085/LBC). Listed Building Consent for alterations to glazed screen between the kitchen and Justice Hall and replacement of 2 fireplace surrounds.
  - **Resolved** that planning application 21/00085/LBC is SUPPORTED.
- f. 25 Manning Avenue, Cullompton (21/00094/TPO). Application to reduce height and thin by 3-5 metres the canopy of 1 Oak tree protected by Tree Preservation Order 97/00013/TPO.
  - **Resolved** that the council will accept the determination of the Planning Authority in the matter of planning application 21/00094/TPO.
