You have personal rights, namely the right to access, oppose, rectify and delete data, the right to limit the processing thereof, the right to lodge a complaint with a supervisory authority and the right to define guidelines for the retention, deletion and disclosure of your personal data in case of death; your personal rights may be exercised by contacting the Afnic legal affairs department at juridique @afnic.fr.
